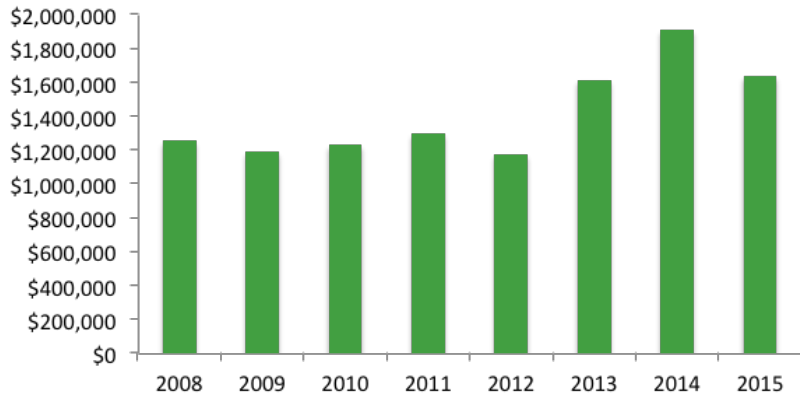

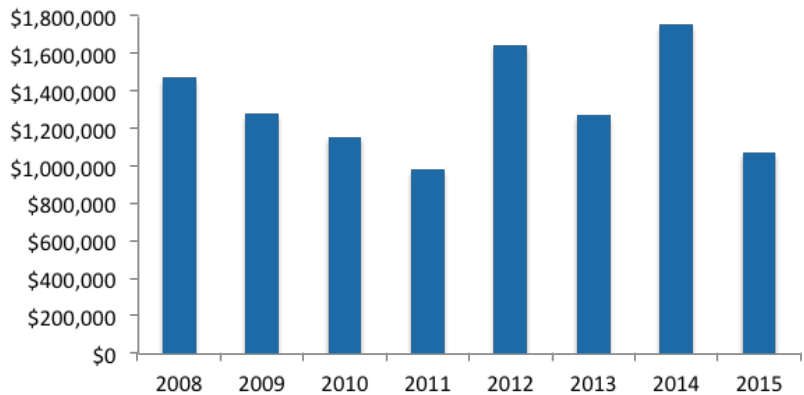
Because of the generous financial support of more than 23,000 ADPAC members, we raised \$1,635,558 in 2015, allowing the PAC to contribute \$1,067,638 to federal candidates and committees.

ADPAC Philosophy of Giving

ADPAC considers many factors before contributing to a candidate for U.S. House or U.S. Senate. Among these are committee assignments, accessibility in Washington and in the state/district, leadership positions and interest in oral health and dental issues. No incumbent or candidate is entitled to receive funds. States may always choose not to give to an incumbent.

Though all committees perform important work, only certain committees have jurisdiction over health care, dentistry, taxation, small business and other issues. Below are committees that are key to dentistry.

Senate Committees

Priority committees for dentistry in the Senate are Finance, Health, Education, Labor, Pensions (HELP) and Appropriations. All Senators are eligible for a maximum contribution to both their primary and general election funds and leadership PACs when they are not up for re-election.

No contribution is made without the approval of the Constituent Society. Contribution requests are sent to and must be approved by the constituent society Executive Director, the Member of Congress' Action Team Leader and the ADPAC Board member representing the state.

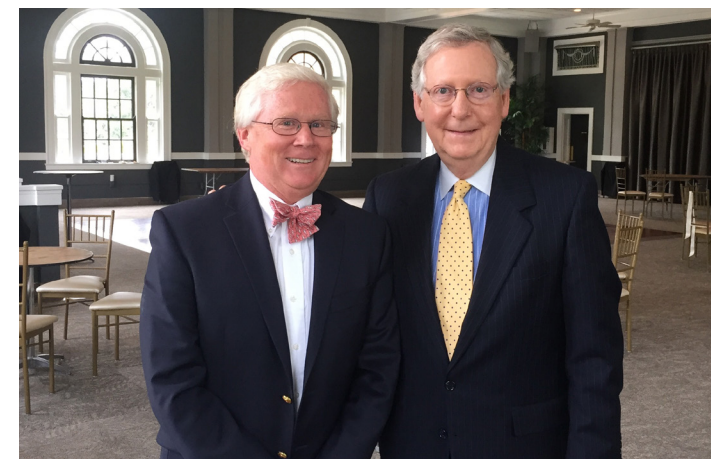

State Dentist Legislator Tracking

In 2014, ADPAC began tracking dental legislators on the state level to provide financial assistance when certain criteria are met and state law allows.

ADPAC Criteria for Giving to State Candidates:

1. Candidate must be a member of the ADA.
2. Candidate must receive full financial support from their state PAC.
3. Candidate should have financial support from local dentists.
4. Candidate must receive support of the state Executive Director, President, and PAC Chair.
5. No more than \$1,000 may be spent on a candidate in an election cycle (election cycles include primary, run-offs, and general elections).
6. These rules apply to dentists running at the state level, for their state legislature or a statewide office.
7. No support will be given if it is prohibited by state law or in instances where the state law makes Federal PAC giving too cumbersome.

There are now more than 25 state legislators who are dentists. Dental candidates supported by ADPAC at the state level include:

Grassroots Advocacy

Engage:

Since its launch in October of 2013, ADA Engage has been our primary platform for advocacy and member engagement on the state and federal level. ADA Engage allows our members to advocate our issues directly to their elected leaders. Over the course of the last year, we have steadily increased enrollment and participation. The key things to note about ADA Engage include:

- In 2015 over 23,000 letters were sent to Members of Congress, more than doubling our 2014 total.
- Over 8,500 dental advocates took action on at least one issue this year.
- The ADA's Grassroots program added 2,100 new advocates.

Advocacy at America's Dental Meeting:

This year at America's Dental Meeting in Washington, D.C., the ADA Grassroots Department experimented with a live call to action. During the event, participants were encouraged to take action through their cell phones and other mobile devices. Over 200 people sent messages to their Members of Congress during this call to action.

Campaign School:

Each year, ADPAC, along with other health organizations, hosts a campaign school for members that are planning on, or thinking of, running for office. Campaign school is designed to show participants what it takes to run a successful campaign for any level of office. In 2015, ADA members made up the largest contingent of attendees.

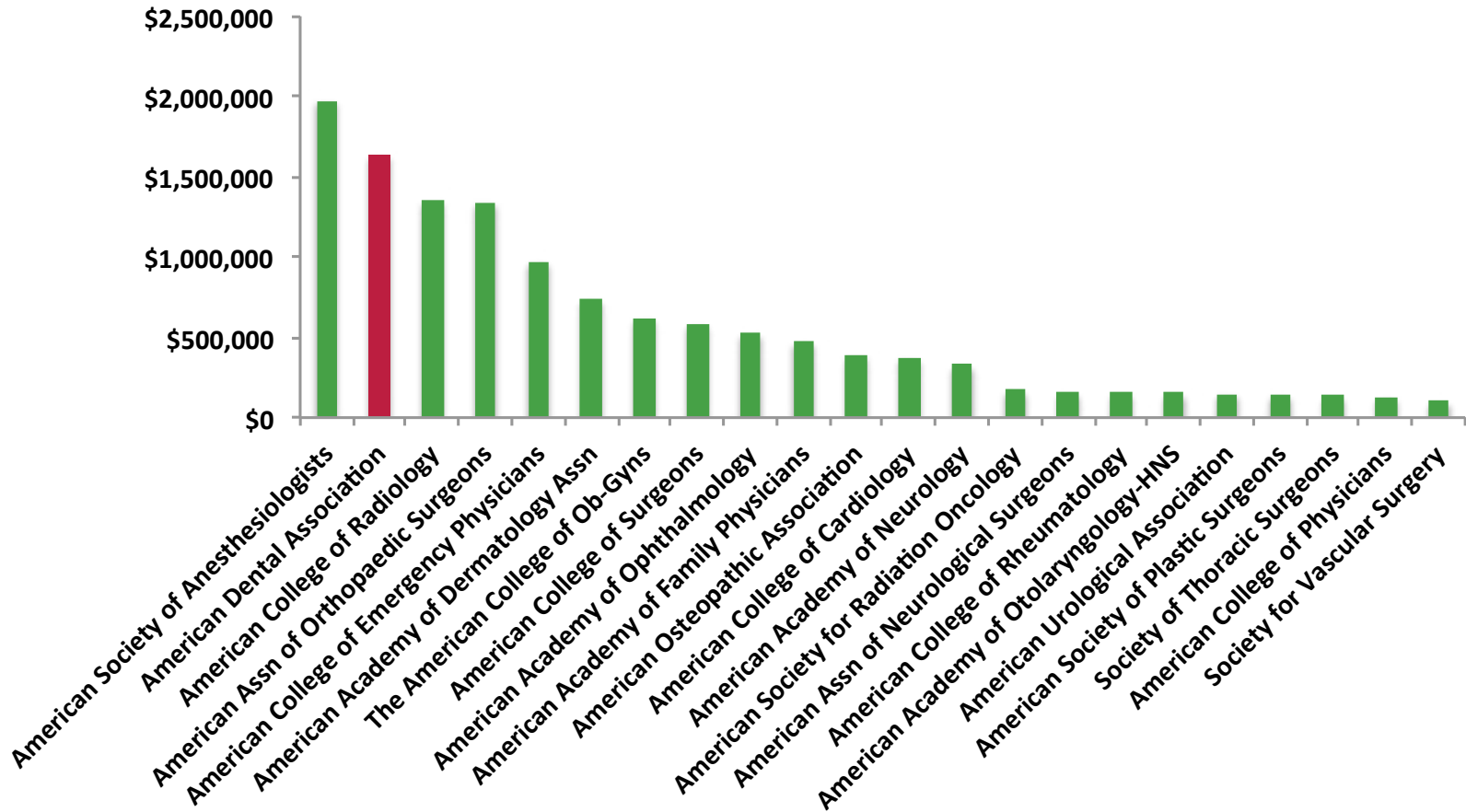
2016 Election and Beyond:

As we enter into 2016, ADPAC, through its grassroots efforts, will begin a voter registration, education and activation campaign. Through our research we found that only 69 percent of dentists are registered to vote, only four points higher than the general population. More concerning is that we also learned that dentists vote at the same rate as the general population with 58 percent of registered dentists actually voting. Throughout 2016, ADPAC will run voter registration drives in targeted Congressional districts to drive up the number of dentists registered to vote as well as run a Get Out the Vote (GOTV) program to all registered dentists. Although raising money remains our primary method of influence, ADPAC believes that through these programs we can raise the influence of our members and the effectiveness of our Action Alerts and lobbying efforts.

How We Stack Up

We are not far behind from the top performing health care PAC in the United States. Through the continued support of thousands of dentists from around the country, the ADPAC board believes it can become No. 1 by the end of 2016.

American Dental Association Independent Expenditures (IEs)



The Code of Federal Regulations defined an independent expenditure as an expenditure for a communication “expressly advocating the election or defeat of a clearly identified candidate that is not made in cooperation, consultation, or concert with, or at the request or suggestion of, a candidate, a candidate’s authorized committee, or their agents, or a political party or its agents.”

ADPAC has engaged in Independent Expenditures for dentists running for office since 2010.

In 2015, over \$92,000 was disbursed in independent expenditures on behalf of Dr. Ed Holliday, who ran unsuccessfully in a Special Election to fill the vacated 1st Congressional District in Mississippi.

It is likely ADPAC will engage in independent expenditure activity in 2016.



Legislative Accomplishments and Priorities



As a political action committee, ADPAC does not lobby. However, it does play a critical role in supporting the ADA’s direct advocacy efforts by helping to elect candidates who understand dentistry, recognize the importance of oral health, and are responsive to the dentists in their home districts. ADPAC also provides funding and logistical support to the ADA Grassroots Action Teams, thousands of dentists who hand-carry the profession’s message to lawmakers, both in Washington and at home. With ADPAC’s backing, the ADA has in the past year achieved a number of legislative accomplishments, while other priorities are ongoing.



For Your Dental Practice

Permanent Increase of Section 179 Expensing Deduction. The ADA led the way for a permanent extension of Section 179 expensing, which allows for deductions of new equipment and property up to \$500,000, with the deduction phased out for investments exceeding \$2 million.

Two-Year Delay of Medical Device Tax. The ADA participated in a large coalition that advanced legislation to repeal the 2.3 percent excise tax on medical devices. A two-year delay provides additional time for the ADA and others to work to eliminate the tax in the future.

Reverse the Medicare Part D Prescriber Requirement. The ADA is continuing to pursue a two pronged approach to the issue of enrolling in or opting out of Medicare as required by the Medicare Part D regulation. While the ADA fights for legislation to repeal this provision, the ADA is providing the best and most useful information for members to comply.



Two-Year Delay of Cadillac Tax. There is a two-year delay of enforcement of the “Cadillac Tax”, which would impose a 40 percent excise tax on high-cost employer-sponsored health plans. The delay provides additional time to address the unintended consequences associated with the tax, such as the adverse effects on FSAs that are used by many patients to pay for dental care.

Reform ERISA. The ADA advanced legislation that would help consumers receive the full value of their dental coverage. H.R. 1677 requires all self-insured health plans that offer dental benefits to provide uniform coordination and assignment of benefits.

Amend the McCarran-Ferguson Law. The ADA advanced legislation that would authorize the Federal Trade Commission and Justice Department to enforce federal antitrust laws against health insurance companies engaged in anticompetitive activity. H.R. 494 has 96 cosponsors.

For The Dental Profession

Upheld Prohibition on Use of Funds for Alternative Dental Health Providers. The ADA defeated efforts to allow the Department of Health and Human Services to use funds to train or employ alternative dental health care providers, as authorized in the Affordable Care Act (ACA). This prohibition has been in place for more than five years.

Fought for Military Dental Research Funding. Funding will continue at \$6 million. Military research units address dental disease and battle injuries.

Defeated Efforts to Reduce the Rank of the Chief Dental Officers serving in the Armed Forces. The Senate version of the National Defense Authorization Act (S. 1376) included a provision to reduce the rank of the Army, Air Force and Navy Chief Dental Officers. The ADA lobbied against these provisions and won.

Improving Medicaid. The ADA, along with the American Academy of Pediatric Dentistry, submitted comments to the Centers for Medicare and Medicaid Services on a proposed rule that aims to align Medicaid managed care plans more closely with plans offered in the commercial market. The proposed rule would require Medicaid managed care plans to adhere to a minimum loss ratio, provide actuarially sound rates and ensure network adequacy among other requirements. Similar requirements are already in place for any plans seeking certification as a qualified health plan to be offered in the marketplaces.

Non-Covered Services Legislation. The ADA, along with the American Optometric Association, helped craft the “Dental and Optometric Care Access Act” (DOC Access Act), H.R. 3323, which prohibits federally regulated dental or vision benefit plans from dictating what a doctor may charge a plan enrollee for items or services not covered by the plan.

Increased Support for the “Action for Dental Health” Bill. H.R. 539 will allow state organizations to qualify for oral health grants to support activities that improve oral health education and dental disease prevention. The ADA has secured 80 bipartisan cosponsors.

For Your Patients and the Public

Expanding Flexible Spending Accounts. H.R. 1185 would increase the annual maximum contribution to flexible spending accounts to \$5,000 and permit rollover of all unused monies in the account.

Fluoridation. The ADA obtained a statement from the Surgeon General endorsing community water fluoridation, and also advanced a House resolution commemorating the 70th anniversary of community water fluoridation. The ADA also secured a \$2 million increase in funding for the CDC’s Division of Oral Health for FY 2016.

Funding for the Indian Health Service, Division of Oral Health. With strong ADA support the dental account received nearly \$178.3 million in funding for fiscal year 2016, more than a \$4.3 million increase.

Funding for Dental Prevention, Access and Research Initiatives. The ADA and other dental organizations successfully lobbied for additional fiscal year 2016 funding for dental access and prevention. This includes over \$415 million for the National Institute of Dental and Craniofacial Research, which is a \$17 million increase; \$35.9 million for oral health training programs with \$10 million set aside for general dentistry residencies, a \$1 million increase; and \$10 million for pediatric dental residencies, also a \$1 million increase.

Promoting Healthier Diets. The ADA lobbied for additional fiscal year 2016 funding for research examining the long-term effects of added sugars. The ADA helped secure a separate line for added sugars in a Food and Drug Administration (FDA) proposed rule to revise the Nutrition Facts label(s) required for packaged foods. The ADA was part of a coalition that helped broaden the base of scientific literature federal agencies may draw from when formulating the next iteration of the Dietary Guidelines for Americans.

Preventing Tobacco Use. The ADA successfully petitioned the FDA to deny a tobacco company’s modified risk tobacco product application to label ten snus tobacco products as less harmful to human health than smoking.

E-cigarettes. The ADA successfully kept language out of the appropriations process that would have shielded electronic cigarette manufacturers from the FDA approval process that regulates the latest generation of tobacco products. The FDA approval process helps remove those products from the shelves if the agency deems them harmful.

ADPAC is a federally registered political committee and the contributions it receives are used to support federal candidates and committees. Contributions to ADPAC are voluntary and any person has the right to refuse to contribute without reprisal. The contribution guidelines are merely suggestions and a person may contribute more, less or not at all without concern of favor or disadvantage by the ADA. Corporate donations will not be used by ADPAC for contributions but will be used exclusively to pay for the administrative and operating expenses for ADPAC or related political activity. Contributions are not deductible as charitable contributions for federal tax purposes. Federal law requires ADPAC to request the name, address, occupation, and employer for each person whose contributions exceed two hundred dollars (\$200.00) in a calendar year.
